

Director of Student Activities and Recreation Job Posting

Job Summary:

The Director of Student Activities and Recreation is responsible for the development, implementation, and administration of programs and activities designed to to enrich the student experience, promote an active and engaged student culture on campus and contribute to the retention of college students, in a co-curricular environment.

Duties and Responsibilities: Campus Activities Board

- Serve as staff advisor to Campus Activities Board and assist student organization in planning and implementing student events and programs
- Facilitate CAB budget and use of funds apportioned to organization

Student Programming

- Collaborate with faculty, staff, administrators and community partners on delivery of awareness and observance programs and events to students e.g., Hispanic/Latinex Heritage Month, National Coming Out Day, Domestic Violence Prevention Month etc.
- Plan and implement 24 student-focused activities and events throughout the academic year (4 per session x 6 sessions). This will include working various hours and some weekends
- Plan and implement Student Activities portions of Orientation, Engage and Welcome Week each fall.

Student Event Spaces

- Collaborate with other departments, campus and community partners to maximize the use of campus facilities for student engagement opportunities
- Responsible for the use of audio and visual components and event set-up for student and departmental events
- Oversee all departmental use of Columbia Theater and serve as primary booking agent and manager for space as used for student-focused events (concerts, speakers, films etc.)
- Coordinate Co-Curricular Records and event tracking system
- Plan, curate and deliver Cinema International film series

Intramural Recreation Program

 Provide significant and high-quality opportunities in a variety of indoor and outdoor intramural activities to satisfy the diverse needs of students, faculty and staff

- Plan and implement intramural program to include two Fall, two Winter and two Spring tournaments (e.g., kickball, ultimate Frisbee, pool, video games etc.)
- Direct, organize, supervise and evaluate all intramural programs and manage intramural budget
- Create and maintain web site for online registration of events, tournaments, leagues, etc.
- Develop E-Sports (competitive video gaming) program to include programmatic budget oversight, recruitment, development of video gaming lounges, practice/training and league participation
- Maintain records relative to participation and equipment inventory
- Authorize intramural equipment purchases and repairs
- Design and purchase t-shirts or other marketing, collateral materials for intramural programs
- Hire, train, and supervise intramural student employees including the creation of work schedules
- Attend and supervise intramural events and referee when necessary
- Create and maintain intramural manual of operations

Student Activities Center/Union

- Oversee planning, renovations, budget and daily operations of forthcoming Student Activities Center.
- Review and provide input on designs and interior and exterior elements of SAC to create a student-focused environment
- Establish hours of operation, access and student staffing of SAC
- Hire, train, and supervise student employees including the creation of work schedules
- Plan and purchase all furniture and equipment for SAC, interface with facilities for maintenance and repairs and manage ongoing upgrades and replacement of furniture and equipment
